#### **Pocket Neighborhood Breaks Ground** ECIA's non-profit, East Central Development Corporation



(ECDC), broke ground on a 10-home \$2.5 million housing development known as the Bear River Cottages in Maquoketa located in Jackson County on Friday, September 27, 2019. Jackson County Board of Supervisors, City of Maguoketa, ECIA Council and ECDC Board of Directors, EIRHC Housing Trust Fund, Maquoketa State Bank, Federal Home Loan Bank, Iowa Finance Authority, Iowa Area Development Group, Jackson County Community Foundation, McDonough Foundation, Iowa Realtors Association, Maquoketa Municipal Electric Utility, Jackson County Economic Alliance, Habitat for Humanity, University of Iowa Sustainable Communities program, Marty Belliu our contractor, and

Burrington Group Engineers, are all partners on this exciting project.

To address the workforce housing shortage in eastern Iowa, in 2015, spun off a private nonprofit known as ECDC. ECDC is the developer of the 10 home "pocket neighborhood" in Maquoketa. A pocket neighborhood is a small scale community within the larger community. Homes are smaller in size, 1064 sq ft., all with front porches that face in toward a common garden and community space. The "pocket neighborhood" creates a sense of belonging and promotes community spirit. All homes have full basements, two car garages, raised garden beds and will be priced at or below \$150,000. Each buyer will also receive a \$10,000 down payment assistance. All buyers

must meet income qualifications at the time of application. This is a pilot project and the first pocket neighborhood in Eastern Iowa. ### ECIA Awarded \$3M HUD Lead Grant HUD understands the close connection between health and housing and their 2019 awards directly support their efforts

to identify and clean up housing-based health hazards like lead, moisture intrusion (mold), electrical hazards, pest issues, ventilation, energy efficiency, etc. The East Central Intergovernmental Association was awarded

\$2,999,996 in Lead Based Paint Hazard Control grant program

funding and \$300,000 in Healthy Homes Supplemental funding. Throughout a 42-month performance period (December 2019 through May 2023) ECIA will address lead hazards in 120 units throughout



Dubuque County, resulting in healthier and safer homes for low to moderate and very low-income families with young children. In addition, these 120 unites will receive healthy homes assessments and financial assistance to improve health and safety deficiencies in the property. It is anticipated, on average, a property would be awarded \$15,000 for lead hazards and \$2,500 per property for health and safety deficiencies. Match dollars of \$488,000 have been pledged by Dubuque County, participating landlords, local hotels, and nonprofits to provide local support and equity in the project.

This endeavor will require collaboration and partnerships with many Dubuque County

departments, non-profit agencies, faith-based organizations, and other private and public

concerns to increase awareness and provide education to citizens residing in homes built prior to 1978. Dubuque County has over 10,500 homes built prior to 1939, each with a high propensity of having lead hazards. This program will be a catalyst in improving deteriorated older housing stock, and ultimately protecting the citizens (primarily the young children) within our County. According to Dubuque County Board of Supervisors Chairperson, Dave Baker, "Dubuque County is proud to partner with ECIA and other community associates (landlords, hotels,

non-profit agencies and faith-based organizations) to identify and mitigate lead hazards in homes throughout Dubuque County. The end result will be safer and healthier homes for moderate-to-low income families. This approximately \$3.3 million grant will provide the impetus for improvement in older housing stock currently in a state of deterioration and protection for our Dubuque County citizens, especially our younger children". New Bus Storage Facility Opens in Earlville The Region 8 Regional Transit Authority (RTA) of Dubuque, Delaware, and Jackson Counties cut a ribbon on a new \$420,000 Bus Storage Facility in Earlville, Iowa located in Delaware County on Monday,



City of Earlville to acquire and deconstruct an old car dealership that sat vacant for years. The property was a nuisance and brownfields property in the Earlville community. The facility is a 5000 square foot preengineered steel frame building with a wash bay, restrooms and break room housing 6 to 8 buses and up to 3 mini-vans. This project could not have happened without the RTA partners and resources from various agencies. Those partners included the Iowa Department of Transportation (DOT), City of Earlville, Iowa Department of Natural Resources (IDNR), Environmental Protection Agency (EPA), Dubuque/Delaware County Engineer, and ECIA. A \$320,000 grant from the Iowa DOT

September 30, 2019. The RTA worked closely with the

of Earlville and the RTA partnered on land costs and deconstructing the structure on the site with grants from both the EPA and the IDNR. The Delaware/Dubuque County engineer designed the facility at no cost to the RTA. ECIA staff oversaw the procurement, construction oversight and inspections. This project improves the overall safety and security for the RTA fleet while improving the neighborhood and property values in Earlville. RTA
